The narrative should include the gross and net building areas applicable to the project, a description of the major building areas (i.e., operating rooms, laboratories, computer rooms, industrial processes, offices, warehouses) and a brief discussion regarding the following five criteria (if a criterion is not applicable, then state accordingly):

Energy Efficiency Indoor Air Quality Innovation

Operation & Maintenance Cost Effectiveness

3. Submit your schematic, brief narrative and completed form to me for judging at the Chapter level.

Applicants will receive recognition and have the chance to advance to Regional & Society level competition.

Rob is a Mechanical Engineer at Wade Crow Engineering (WCE) in Spartanburg, SC. WCE is a consulting engineering firm that designs heating, air conditioning, piping, and plumbing systems. WCE has designed several LEED buildings, (7) geothermal buildings, and a number of other high tech HVAC concepts. Mostly, these designs apply to schools, but WCE has also designed science facilities, libraries, and high-rise office buildings. No matter who the client is, they increasingly demand higher efficiencies and lower operating costs.

Rob holds a Bachelor of Science Degree in Mechanical Engineering from Clemson University (1995). He began his career with Lockwood Greene in industrial mechanical design. After three years he moved to the smaller Wade Crow Engineering, and has been there ever since. He got his professional engineering accreditation (P.E.) in 2000. Rob is also the Greenville ASHRAE Student Chairman.
