## September Meeting

Program: Wastewater Treatment

Presenter: Victor Walker

Victor Walker moved from Ireland in 1994 and started working in the US as an electronics technician. He worked his way through retail and then into the marine market ending up with a senior sales role. In 2001 he moved to Criteria, a marine service company based in Fort Lauderdale immediately working on a contract for the largest US yacht ever built. Over the next three years he



was heavily involved in the refit as well as the new build markets with total order values of over \$4.7m. He continued in the marine industry with Intelect and ANT as a Project and Business Development Manager working on projects throughout the US and Europe. During this time he became keenly interested in the water/sewage treatment process widely used throughout the marine industry and how this eco-friendly system could be used to automate the water treatment and recycling process, eliminating the need to handle black water.

He has joined with Penumbra in promoting the land based Piranha water treatment system to key decision makers. He truly believes Penumbra's unique approach and philosophy can make a big impact in the environment

#### **Stimulus Funding Information**

In May's newsletter I mentioned some recovery funding information available from ASHRAE. The government affairs advocacy group has put together some literature at <a href="http://www.ashrae.org/advocacy/page/2276">http://www.ashrae.org/advocacy/page/2276</a>

Per the SC Energy Office (SCEO) newsletter the stimulus legislation provides 150 million dollars in funding for energy projects in South Carolina. The SC Energy Office website at <a href="http://www.energy.sc.gov">http://www.energy.sc.gov</a> provides links and information for stimulus funding for schools, energy improvement projects, and federal competitive funding grants. The SCEO will administer approximately \$40 million dollars in grants and low interest loans in energy related projects for schools. \$31 million dollars is available to assist state and local governments improve energy efficiency. We tentatively have a speaker from the SC Energy Office scheduled for October.

#### **International Existing Building Code**

Recently, a code official informed me that reconstruction of a damaged structure has to comply with the International Existing Building Code (IEBC). This was a bit of a dent in my ego since I tend to think that I am pretty well versed on the codes and this one was a mystery. The results of my rapid self taught education are that the International Existing Building Code was not adopted state wide, but individual municipalities were allowed to adopt it. Greenville and Anderson Counties adopted it whereas the city of Greenville has not; and the websites for the City of Spartanburg, County of Spartanburg, and City of Anderson are unclear.

The International Existing Building Code deals with the level of compliance with new codes that a building under repair or renovation has to achieve. Building renovation is placed into one of three categories with each one increasing the level of renovation and compliance with current codes. Chapter 13 presents an alternate means of compliance that I will not attempt to explain in this column.

During my investigation into where the IEBC had been adopted I noticed that the International Property Maintenance Code had been adopted by some of these same municipalities. Another new mystery code.
